A winter overnight parking ban advisory will be issued as soon as Environment Canada forecasts a snow accumulation of 5 to 10 cm or more for the Ottawa-Gatineau area.

The advisories are issued no later than 3 p.m.*

**A Note About the Service Providers**

*Although Gatineau issues the advisories by text message (SMS) free of charge, you may be billed by your telecommunications service provider. Text messages (SMS) are compatible with most mobile devices.*

**GENERAL CONDITIONS**

1. Permits costs **\$87** and are non-refundable.
2. General permits for winter overnight parking are valid from **December 1, 2018, to April 1, 2019.**
3. Permit holders may park along the side of a public road as long as they comply with the posted signs.
4. Residents must provide a valid driver's licence indicating an address in Gatineau, or any other supporting documentation stipulated in by-law 300-2006 for special cases (e.g. students and contractors).
5. Gatineau may cancel a permit or revise the permit rate at any time during the calendar year. In such a case, Gatineau will inform permit holders of its decision twenty (20) days in advance.
6. Gatineau assumes no responsibility for any loss, damage, theft, accident or other incident that may occur to the vehicle or its contents.

I have read the above-stated general conditions related to the issuance of a general permit for winter overnight parking, and I agree to review any by-laws applicable to winter overnight parking on the Gatineau Web site (by-law 300-2006).
